**III. BOARD OF TRUSTEES:**

The Maximum No. of trustees shall be ~~nine~~ *seven*. The founder trustees shall form the board and be the trustees for life. The trustees shall elect amongs themselves a President, one Secretary. In case of vacancy caused by death, resignation or otherwise the remaining trustees may fill up the vacancy co-opting may other person as a member of the Board of occurrence up of the vacancy, till the vacancy or vacancies are filled up the remaining trustees, shall constitute the Board of trust, and in no case the number of trustees shall be less than ~~xxx~~ three.

**IV. MEETINGS:**

The quorum for the meeting shall be three, any two trustees may be in writing requisition the secretary to convene a meeting of the board of trustees clearly indicating the subject matter to ~~the~~ discussed, on accept of such a requisition the secretary shall call for a meeting after g ving five days clear notice. Trustee must have to be attend such meeting and decision is passed by the majority.

**V. POWERS OF THE BOARD OF TRUSTEES.**

To perform and exercise the following acts, deeds and powers:-

- a) Demand all moneys payable and receivable by the trust and give effectual receipts and discharge for the same, by themselves jointly or through their accereditd agents.
- b) Conduct or defend or compromise legal actions, appoint legal Advisers for conducting of alegal proceedings and to perform all such acts including incidental to them by themselves or through their accereditd agents.

III. BOARD OF MEMBERS  
The Maximum No. of members of the Board shall not exceed fifteen. The fifteen shall include the President, the Secretary and ten members, of whom five shall be nominated by the Government and five shall be elected by the members of the Board. The members shall hold office for a term of five years, but they shall be eligible for re-election or re-nomination. The Board shall meet at least once in a month.

IV. MEMBERSHIP  
The Board shall have the power to co-opt such persons as it may think fit to serve on the Board. The members shall be eligible for election or re-election or re-nomination. The Board shall have the power to suspend or remove any member if he/she is found to be incompetent or incapable of discharging his/her duties. The Board shall also have the power to suspend or remove any member if he/she is found to be guilty of any offence involving moral turpitude.

- c) Execute all documents, relating to the immoveable properties or to any loan secured or obtained by the trust.
- d) The trustees shall enter into contracts or agreement with third parties as may be decided upon by the majority of trustees in writing at a meeting duly called for the purpose.
- e) The trustees shall act jointly and if any differences of opinion arises at any time amongst them in relation to the doing or for bearing to do any thing or otherwise the opinion of the majority shall prevail, and be binding, and shall be effectually carried out.
- f) The Board of trustees is fully empowered to carryout the aims and objects of this trust in any manner it deems fit.

VI. THE MANAGEMENT.

The Management and control of the properties and affairs of the trust shall be vested in the Board and in the V. Board of trustees. The trustees by themselves or through duly authorised agent or agents employed by them manage and deal with the trust property in such manner as may be most beneficial to the interest of the trust.

VII FUNCTIONS AND POWERS OF THE PRESIDENT:

- a) The president and in his absence the General secretary shall preside at the time of the Board. If both are absence the trustees shall elect one among themselves as President of such meeting.
- 1) The President also possesses the powers of issuing appointments, selection. The selection can be promulgated only during the recess of the Trust Board meeting with two Third Majority.
- 2) The President is Chief Administrative officer regarding planning programme of the developing work of the trust.
- 3) The President shall be held responsible for the official correspondence if the secretary absence.
- 4) In financial procedure bill or bills cannot be claimed or introduced in the Trust Board meeting without the prior permission of the president.

- 5) He appoints the Finance audit Committee constituting of two co-trustees or bonddear trustees. In that committee treasurer may preside over the audit committee.
- 6) The president shall appoint sub-Committees for administrative purposes within Founder- Trustees only i.e. appointments, selection or rejection plannings and programmes etc.

**B) GENERAL SECRETARY:**

The General Secretary shall be incharge of and responsible for the safe custody of all records relating to the administration of the trust and its properties. She shall commence the meetings of the Board and trustee under the directions of all the members and maintain regulated records and all proceedings of such meetings. All correspondence and all financial statements and returns required in the connection with the Management of the trust will be carried and prepared by the General Secretary shall be the chief Executive officer of trust.

- X. The Office of the Trustees shall be honorary but they are entitled to draw such allowances as are Prescribed by the Board from time to time for carrying out their duties.
- a) Any trustees who becomes a Bankrupt, Lunatic, convicted or a Criminal offence, involving moral turpitudes or neglects to take interest continuously for a period more than six months or physically incapaciated or remain outstand side India continuously more than 12 calender months shall cause to be a trustee of these presents.
- b) Any trustees may retire by a giving notice of one calender month in writing of his intentions to do so.

XII a) The Trustees are wholly indemnified against any expenses and losses incurred or suffered or any payments made by them in the administration of the trust and such expenses losses and payments shall be borne by the trust and none of the trustees shall be in any manner be personally liable or responsible for the same.

b) The trustees may reimburse themselves or pay and discharge out of the said trust properties all expenses incurred in or for the executions of the objection of the trust and in exercise of the powers vested in them.




